Rule change places new limits on claims

Trainers will be limited to one claim slip per horse, under a rule change expected to take effect by the end of April.

If a trainer is named on more than one claim form, a drawing of the forms will be conducted to determine which claim will be entered.

The new rule also prohibits owners employing the same trainer to claim horses from one another.

The Maryland Racing Commission gave final approval for the rule change at its March 18 meeting.

Medication alert

While Maryland is proceeding judicially and awaiting results of research before taking action on rules regarding steroids, neighboring states will implement race-day bans in the near future.

At Pennsylvania tracks, the ban begins on April 1.

Delaware and Virginia will have rules in place for the opening of the Delaware Park meet (on April 19) and Colonial Downs (on June 9).

Maryland horsemen shipping to race in these states are advised to familiarize themselves with the rules and procedures, so as to avoid potential penalties.

MTHA's Board of Directors election

The MTHA's election for the Board of Directors, held every three years, will take place again this summer. All 15 directorships will be up for election. Terms are three years.

Legislative update

With the state facing a gaping budget shortfall, the MTHA withdrew bills that had been introduced in both the Senate and House to establish a purse enhancement. The MTHA took this action upon the advice of legislative leaders; it was evident that the bills would not pass.

"MTHA representatives are pursuing other means to possibly secure some form of enhancement for purses and the breeders' fund," said MTHA President Richard Hoffberger.

"While the odds against this happening may be insurmountable, we will continue to advocate until the end of the legislative session, in the hope of obtaining funds to tide us over until prospective slots revenue becomes available," added Mr. Hoffberger.

In other legislative action: The

MTHA, along with various segments of the industry and the Maryland Racing Commission, is supporting a bill that would apply the customary formula for division of revenue between the Purse Account and Maryland-bred Fund to prospective monies derived from slots.

In the slots bill approved last November, the formula is set at 85/15—marking a departure from the 89/11 split that has been in effect for many years. Part of the intent of the industry's 15-year agreement signed in 2006 was to establish and maintain divisions of revenue; thus the change is in direct violation of that agreement.

Senate Bill 784, to correct this portion of the slots bill, passed the Senate by an overwhelming margin and is now under consideration in the House.

Make sure you—and your employees—are registered to vote

Maryland's racing industry has a huge stake in the outcome of the November 2008 statewide election. The ballot will include a referendum asking voters to say YES or no to the slots program.

This will be the most important vote that many of us will ever cast.

Now is the time to ensure that you are registered to vote in the election. If you have not voted recently, or you have moved since the last time you voted, your registration may not be valid.

Industry must get behind slots referendum

Frederick W. Puddester, a former Maryland budget secretary, is heading a statewide effort to promote the passage of the slots referendum.

The effort, like all political campaigns, will be significant.

All major groups that can benefit from the passage of slots have been asked to participate and help pay for the effort.

The MTHA agreed to participate, even as the group was being formed.

Magna Entertainment Corp. has yet to make a commitment to help fund the lobbying effort for the slots referendum to take place in November.

Its reluctance apparently is based on concerns that Laurel Park is not named as a site in the slots legislation that was approved in the 2007 special session of the Maryland General Assembly.

"We obviously hope that Magna will take this issue into further consideration, and throw its considerable weight behind the cause," said MTHA President Richard Hoffberger.

"While the legislation is not site-specific, it was clearly designed to include Laurel as a site," Mr. Hoffberger continued. "If Magna joins in efforts to secure passage of the referendum, the likelihood of passage increases and so do Magna's chances of having slots at Laurel.

"If Magna doesn't participate in the slots effort, its chances of being awarded a license could be dim."

Added Mr. Hoffberger: "Obviously, it's important for all stakeholders to help fund the initiative. The teachers' union has stepped up to the plate, along with various segments of the racing industry, including, of course, the MTHA."

Meanwhile, Magna is noncommittal.

"Do I think we are leaning toward being supportive? Yes, I do," Magna's executive vice-president of racing, Scott Borgemenke, told *Thoroughbred Times*. "I would be less than honest with you if I said we are on board."

IN MEMORIAM

Barbara M. (Bobby) Kees, one of Maryland's longest-active trainers, died on February 25 at the age of 86.

Mrs. Kees, who bred and raced horses from her Road's End Farm in Sparks, became a licensed trainer in 1950. Her best success came in the 1990s with a succession of homebred stakes-winning half-brothers—Waited, Mr. Moby Dick and South Bend.

Thoughts and comment

As a Marylander—born and raised—and a horseman for more than 20 years, I have been among those who lobbied long and hard for a slots program in this state.

It was extremely gratifying when our legislature took long-awaited action in November 2007, and approved a slots plan that will—if enacted—provide funding for numerous vital services within this state while ensuring the future of one of our most important industries, horse racing.

Now I feel compelled to take my message to my fellow voters, who will have

the final word by marking your ballot either "yes" or "no" to this slots plan in the November 2008 general election.

The stakes are extremely high.

Slots in the surrounding states of Pennsylvania, Delaware and West Virginia draw billions of dollars annually from Marylanders who travel beyond our borders for a form of entertainment that is not as yet legal here.

Revenue from those gaming sites has bolstered the economy in neighboring states, and all but crushed the horse rac-
