Rosecroft Raceway battles on against Thoroughbred industry

Rosecroft Raceway, bankrupt and out of business, continues to battle the Thoroughbred industry.

Rosecroft's parent company, Cloverleaf Enterprises Inc., is continuing to press its lawsuit filed last year against the Maryland Jockey Club, MTHA and several other Thoroughbred groups, alleging that the Thoroughbred industry engineered a "boycott" to prevent Rosecroft from receiving simulcasts of Thoroughbred races.

Meanwhile, state lawmakers from Prince George's County are reportedly considering legislation that would strip the Thoroughbred industry of its share of slots revenue if it fails to return simulcast signals to Rosecroft.

These efforts are being led by Delegate Veronica L. Turner (D, Distr. 26, Prince George's County).

"Rosecroft has gone to extreme lengths to avoid accepting responsibility for its own demise caused by its 'scorched earth' strategy that has failed," said MTHA Counsel Alan Foreman. "The lawsuit is part of CEI's strategy to blow up the 2006 industrywide agreement that established the terms under which Rosecroft is permitted access to Thoroughbred signals. We are confident our side will prevail as the facts become known in court and in Annapolis."

Rosecroft has not conducted live racing for more than two years; the harness track near Oxon Hill, Md., closed operation completely on July 1.

Referendum gets go-ahead from state's highest court

After losing in the first round, the campaign for a voter referendum on slots at Arundel Mills mall emerged victorious.

On July 20, Maryland's Court of Appeals, the state's highest court, ruled that the zoning issue should be placed on the county ballot in the November general election.

The decision overturned the previous month's ruling by Anne Arundel County Circuit Court Judge Ronald A. Silkworth.

Using far-fetched reasoning, Judge Silkworth struck down the ballot referendum on the basis that the legislation that grants zoning rights for Baltimore-based Cordish Cos. to construct a casino on the mall parking lot is part of an ap-

propriations package. State law does not allow appropriations to be put to referendum.

The MTHA, which has consistently supported slots at race tracks, hailed the decision of the Court of Appeals.

"Obviously, more hurdles remain to be overcome," said MTHA President Richard Hoffberger. "But we are headed in the right direction."

If a majority of Anne Arundel County citizens chooses not to have slots at the mall, Laurel Park could regain consideration as a slots site.

But the process is not clear, even to Donald Fry, chairman of the state's Video Lottery Facility Location Commission, which granted the Cordish Cos. a license

O'Malley, Ehrlich take differing stands on AA County slots

The two leading candidates for Maryland's gubernatorial election in November—current Governor Martin O'Malley (D) and former Governor Robert L. Ehrlich, Jr. (R)—hold widely different views on the future of slots in Anne Arundel County.

On July 20, Gov. O'Malley issued the following statement:

"Today, the Maryland Court of Appeals affirmed the right for the people of Anne Arundel County to have their

voices heard on whether slots should be located at Arundel Mills Shopping Mall, and I support that decision. I have always preferred that these slots locations be limited to race tracks, but this is a local zoning issue that should be decided by the people of Anne Arundel County, just as Marylanders overwhelmingly approved the slots referendum in 2008."

Mr. Ehrlich is a partner in a law firm, Womble Carlyle Sandridge & Rice, that has done considerable work for the prospective Arundel Mills mall site developer in order to bring slots to the mall.

According to WBAL.com, Mr. Ehrlich supports bringing slot machines plus fine dining and live entertainment to the Arundel Mills site.



Penn National completes purchase of interest in Maryland tracks

MI Developments Inc. (MID) and Penn National Gaming Inc. (Penn) have officially established a joint venture to own and operate Laurel Park, Pimlico Race Course (including the Preakness and related property) and Bowie Training Center.

The Maryland Racing Commission approved the transaction following a hearing on June 28, and closing took place on June 30.

The venture involves a complex corporate structure, with both companies operating through subsidiaries.

But the "bottom line," as explained by Bruce Spizler, Senior Assistant Attorney General and Counsel to the Maryland Racing Commission, splits ownership of racing operations 51-49 percent, respectively, between MID and Penn. The percentage is reversed to 49-51 percent for any future gaming operations.

Penn National Gaming owns and operates the Hollywood Casinos at Charles Town and Penn National and is scheduled to open Maryland's first slots facility, located in Perryville (Cecil County), this fall.

to operate as many as 4,750 slot machines at Arundel Mills. The Cordish Co. will not automatically lose its license if the referendum passes.

"Slots is going to have to be in the county. The state Constitution says that there will be slots in that area," Mr. Fry

told *The Baltimore Sun*. "The voters will have the opportunity to determine whether they agree or disagree with the County Council's zoning decision. Depending on which way they go, our members will sit down and figure out what we want to do."

Timonium to open on Aug. 27 for seven-day meet

Timonium is gearing up for its 129th season of live racing—a seven-day meet on August 27, 28 and 29 and September 3, 4, 5 and 6.

The track will once again provide a \$10,000 trainer's bonus (divided 4-3-2-1 and based on a point system).

In line with changes instituted last year, the facilities will not be open for stabling and training, and simulcasting will be offered at Timonium only on days when it is conducting live racing.

Maryland's other simulcast facilities, including Laurel and Pimlico, will follow their usual schedules throughout the entire August 27 to September 6 span.

Post time for Timonium is 1 p.m. every day except Sunday, September 5, when it will move up to noon because of a concert.

Admission to the track is included in the ticket for the Maryland State Fair.

particular live racing, are sketchy at best.

Racing never fares well when it operates in direct competition with a casino. Even Arlington Park—a showplace among race tracks—is battling for its life against nearby gambling emporiums.

I've heard the argument that racing and slots draw from different clientele, and there's truth in that. But if casinos didn't draw customers away from the tracks, would New Jersey racing be in its current state of turmoil?

With Arundel Mills just 10 miles down the road, the prospects for Laurel to continue racing, over the long haul, are slim to none.

H. Morton (Morty) Rosen, a longtime owner/breeder, died on July 6. He was 80. A lawyer who some years ago frequently brought issues before the Maryland Racing Commission, Mr. Rosen, was the proprietor of Benray Farm in Westminster.

Frank J. Tambertino, who raced horses in Maryland for many years, died on July 2 at the age of 72.

Dr. William H. (Bud) Wright, 95, a once prominent veterinarian on the New York racing circuit who owned, trained and bred horses at Labadie Mill Farm in Chesapeake City, Md., since the 1960s, died on July 10.

Thoughts and comment

No one would have bet, two years ago, that slots would go anywhere in Anne Arundel County except Laurel Park.

It's been a wild ride ever since February 2009, when Magna Entertainment Corp. failed to put up the application fee, and knocked Laurel out of the bidding.

Now it appears that slots have a real chance to get back on track—both literally and figuratively (see lead article on page 1). And it's hard to see how that can be anything other than great news for our industry.

Although there are some individuals who foolishly believe slots would be

beneficial to the industry if located at Arundel Mills, slots belong at the race track.

I was among those who testified at the zoning hearing last December, urging the Anne Arundel County Council to turn down the proposed Arundel Mills site; since then, my views on this issue have only gotten stronger.

While representatives of the Arundel Mills project have spoken in glowing terms about a future for racing at Laurel in conjunction with slots at the mall, the details regarding the industry, and in
